Code of Criminal Procedure Art. 45.0511(g). RIGHT TO A DRIVERS SAFETY OR MOTORCYCLE OPERATORS COURSE. You may be able to require that this charge be dismissed by successfully completing a driving safety course or a motorcycle operator training course. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the course

Art. 45.057 (h)(i) CCP

A child and parent required to appear before the court have an obligation to provide the court in writing with the current address and residence of the child. The obligation does not end when the child reaches age 17. On or before the seventh day after the date the child or parent changes residence, the child or parent shall notify the court of the current address in the manner directed by the court. A violation of this subsection may result in arrest and is a Class C misdemeanor. The obligation to provide notice terminates on discharge and satisfaction of the judgment or final disposition not requiring a finding of guilt.

DRIVING SAFETY / CHILD SAFETY SEAT COURSE REQUIREMENTS: (Specialized Driving Safety Course)

If you wish to take a **Driving Safety Course** or **Specialized Driver Safety Course** (for Child Safety Seat violations) or a **Motorcycle Driver Safety Course**, you MUST:

1. Enter a plea of NOLO CONTENDERE or GUILTY below, sign and date.
2. Return this form, along with the court costs + administrative fee of **\$134.10** (**\$159.10 if offense committed in a school zone**) payable to **CITY OF FORNEY** (cashier's check or money order ONLY), a copy of your **Driver's License** and proof of **copy of your Insurance BY CERTIFIED MAIL** or in person.
3. **Incomplete forms or forms postmarked after the court date will not be accepted.**

To be eligible for the course, you must meet these requirements:

1. Must make request in writing via **certified mail** or **in person** as directed above.
2. Must not have had course in past 12 months.
3. Must have valid Texas driver's license or permit or proof of active military duty.
4. Must not have or held a Commercial Driver's License.
5. Must not have been exceeding speed limit 25 m.p.h. or more
6. Must not have been in a work zone with workers present.

If you wish to enter a plea of "NOT GUILTY" and desire a trial, please indicate below in the space provided. If you wish to pay your ticket by mail, please enter your plea of NOLO CONTENDRE (no contest) or GUILTY and mail your cashier's check or money order payable to **CITY OF FORNEY** on or before the due date listed on your ticket.

When taking care of ticket by mail, the plea form must be filled out, signed and mailed with a copy of your ticket to the mailing address provided on the reverse side of this form. Or pay by phone at 1-833-303-3772.

NOTICE OF ALTERNATIVES TO FULL PAYMENT OF FINES OR COSTS: The judgment and sentence for the offense you are charged is the payment of a fine and cost. If ordered to pay a fine and cost, and you cannot pay, notify the court immediately. If you are determined by the court to have insufficient resources or income to pay, the court is required to provide you other ways to discharge the fine and costs.

CODE OF CRIMINAL PROCEDURE ART. 14.06. GENERALLY.

IF YOU ARE CONVICTED OF A MISDEMEANOR OFFENSE INVOLVING VIOLENCE WHERE YOU ARE OR WERE A SPOUSE, INTIMATE PARTNER, PARENT, OR GUARDIAN OF THE VICTIM OR ARE OR WERE INVOLVED IN ANOTHER, SIMILAR RELATIONSHIP WITH THE VICTIM, IT MAY BE UNLAWFUL FOR YOU TO POSSESS OR PURCHASE A FIREARM, INCLUDING A HANDGUN OR LONG GUN, OR AMMUNITION, PURSUANT TO FEDERAL LAW UNDER 18 U.S.C. SECTION 922(G)(9) OR SECTION 46.04(B), TEXAS PENAL CODE. IF YOU HAVE ANY QUESTIONS WHETHER THESE LAWS MAKE IT ILLEGAL FOR YOU TO POSSESS OR PURCHASE A FIREARM, YOU SHOULD CONSULT AN ATTORNEY."

Transportation Code § 601.233. FMFR: NOTICE OF POTENTIAL SUSPENSION.

A second or subsequent conviction of an offense under the Texas Motor Vehicle Safety Responsibility Act will result in the suspension of your driver's license and motor vehicle registration unless you file and maintain evidence of financial responsibility with the Department of Public Safety for two years from the date of conviction. The department may waive the requirement to file evidence of financial responsibility if you file satisfactory evidence with the department showing that at the time this citation was issued, the vehicle was covered by a motor vehicle liability insurance policy or that you were otherwise exempt from the requirements to provide evidence of financial responsibility."

Transportation Code § 706.003. DPS FAILURE TO APPEAR PROGRAM CONTRACT FOR ENFORCEMENT OF CERTAIN ARREST WARRANTS.

For a city participating in the OmniBase program, the citation must include a warning that states that if the person fails to appear in court as provided by law for the prosecution of the offense or if the person fails to pay or satisfy a judgment ordering the payment of a fine and cost in the manner ordered by the court, the person may be denied renewal of the person's driver's license.

Transportation Code § 708.105. NOTICE OF POTENTIAL SURCHARGE. A CONVICTION OF AN OFFENSE UNDER A TRAFFIC LAW OF THIS STATE OR A POLITICAL SUBDIVISION OF THIS STATE MAY RESULT IN THE ASSESSMENT ON YOUR DRIVER'S LICENSE OF A SURCHARGE UNDER THE DRIVER RESPONSIBILITY PROGRAM.
